# Dia de los Muertos Celebrations in Nebraska

The traditional holiday Dia de los Muertos, or Day of the Dead in English, has become very popular in the United States in recent years.

Dia de los Muertos is a holiday dating back to pre-Colombian days before the Spanish arrived in Mexico. The holiday is now considered a Catholic holiday and is observed on Nov. 2, with Nov. 1 is observed as Dia de los Inocentes, or Day of the Innocents for children.

Individuals celebrate the lives of the deceased with food, drink, parties, and activities the dead enjoyed in life usually placed on an altar, or ofrenda. Traditional items include marigolds, pan de muerto (bread of the dead) salt, sugar skulls and skeletons especially La Catrina the elegantly dressed female skeleton, images that were made popular by the illustrator Jose Posada.



The following national full-ride scholarships are currently accepting applications.

**Coca-Cola Scholarships** 

The Coca-Cola Scholars Program Scholarship is an achievement-based scholarship awarded to graduating high school seniors each year. Students are recognized for their capacity to lead and serve, and their commitment to making a significant impact on their schools and communities.

The online application will request biographical information and have questions regarding school activities, community activities, academic information and employment information.

Please do not be discouraged by the number of questions and amount of information requested. To stand-out from the millions of high school seniors graduating this year, requires a significant amount of detailed information.

#### Eligibility:

- Student must be current high school or home-schooled seniors attending school in the United States;
- Student must be U.S. Citizens; U.S. Nationals; U.S. Permanent Residents; Refugees; Asylees; Cuban-Haitian Entrants; or Humanitarian Parolees;
- Anticipating completion of high school diploma at the time of application;
- Planning to pursue a degree at an accredited U.S. post-secondary institution:
- Carrying a minimum 3.00 GPA at the end of their junior year of high school.

The award will be based on the cost of tuition, fees, books and living expenses for the 2013-2014 academic year, as well as the availability of grants and other scholarships reported on the financial aid award letter.

# 2013 Latina Summer Academy

Eighty-one Latina high school students from across Nebraska and surrounding states converged on the College of St. Mary in Omaha to participate in the 12th Annual Latina Summer Academy.

The College of St. Mary (CSM) is a private all-girls Catholic university in the heart of Omaha that is dedicated to the education of women. The Latina Summer Academy is a one-week educational symposium offered by CSM to encourage education, leadership and self-confidence in Latina high school students with seminars, field trips, and discussions with local professionals.

"The Latina Summer Academy is an important program for CSM in its commitment to reach out to the local community, specifically to young women from this population," stated Maria Luisa Gaston, Director of Latino Community Outreach. "Through this experience these young women will see the many careers that are open to them in the future if they work hard in high school."

The Academy, which took place from Sunday, June 23 to Friday, June 28, hosted a mix of freshmen, sophomores and juniors who wanted to learn about college life and future careers while still in high school.

The 81 students hailed from 20 different high schools in rural and urban areas including schools in Omaha, Papillion, Crete, Lincoln, Holdrege, and Fremont. Twenty-six students traveled from lowa and Missouri to attend the Academy. The girls represented many nationalities with backgrounds from Chile, Cuba, El Salvador, Guatemala, Mexico, Nicaragua, and Puerto Rico.

This year's theme was "Art or Science? Explore The Connections." CSM

Sisters of Mercy, Academy coordinators and college students served as chaperones and oversaw all activities. The students boarded in the college residence halls and had their meals in the dining hall.

Each day began with classes in science and art; just like a regular college student. Classes were taught by local Latina artists, graphic designers and scientists who shared their own stories to encourage the students they can achieve anything. Each day ended with a topic discussion and questions with their chaperones to promote communication and self-reflection. Wednesday ended with a dinner with various Latina professionals from the Omaha area who shared advice on careers and college. Thursday night featured a showing of the Oscarwinning documentary, "Inocente" and a local documentary on Justice For Our Neighbors.

The Academy concluded with a graduation ceremony followed by a picnic with family and staff on the campus lawn. All of the girls who participate in the Academy became eligible for a special scholarship to the College of St. Mary.

# **U.S. Military Academy Information**

Two Nebraska Congressional representatives are currently accepting applications for U.S. military academy nominations.

Acceptance into a military academy provides a full four-year college scholarship estimated to be worth over \$350,000 including tuition, room and board, medical and dental care and a monthly salary.

Students can expect to be educated in discipline, morals, ethics and military science in an environment that fosters development of teamwork, leadership and character.

The service academies provide a first-rate college education in conjunction with military training in preparation to be a commissioned officer in the U.S. military. Upon entry to the academy, except for the Merchant Marine, you will be on active duty in the military.

academic record (Nominator Form) and an Evaluation of the student's community service and leadership activities (Recommender Form).

Students can usually refer the forms to an educator who agrees to serve as either Nominator or Recommender.

#### Eligibility:

- Student has to be African American, American Indian/Alaska Native, Asian, Pacific Islander American or Hispanic;
- Are a citizen, national or legal permanent resident of the United States:
- Have attained a cumulative high school GPA of 3.3 on an unweighted 4.0 scale or have earned a GED;
- Will enroll for the first time at a U.S. located, accredited college or university (with the exception of students concurrently pursuing a high school diploma) in the fall of 2014 as a full-time, degreeseeking, first-year student. First-time college enrollees can also be GED recipients;
- Have demonstrated leadership abilities through participation in community service, extracurricular or other activities;
- Meet the Federal Pell Grant eligibility criteria;
- Have completed and submitted all three required forms by the deadline.

All forms can be completed online at: www.gmsp.org

Application Deadline: January 15, 2014.

Upon completion, you will serve in the military as an officer in the branch of your academy. If you are a Merchant Marine graduate, you will have several options of service in the government and military.

Upon graduation from the service academy, you will then have a service contract with the government or military. After completion of your service requirement, you will most likely have earned veteran status which then entitles you to a full range of state and federal benefits which may include the VA homeloan, VA compensation and pension, VA healthcare and education benefits.

#### How do I apply?

You should apply directly to the service academies through their websites and seek a "nomination" from your U.S. Representative or U.S. Senator. You may also be nominated to more than one academy. Nominations for the service academies are required for all but the U.S. Coast Guard Academy (USCGA). Applications to the USCGA are made directly to the academy.

#### Basic eligibility include:

- Age: Must be at least 17 years old, but not yet 23 years of age on July 1 of the year you will enter the academy (25th birthday for the Merchant Marine Academy).
- Citizenship: Must be a U.S. citizen.
- Marital Status: Must be unmarried, not pregnant, and have no

## Miss Sanchez Goes To Washington

Opportunity rarely knocks, but having friends and a passion to make a difference often creates its own opportunity, as Janet Sanchez will tell you.

Sanchez, a senior at the University of Nebraska-Lincoln and Scottsbluff native, has been awarded an internship in Washington, D.C., by the Congressional Hispanic Caucus Institute.

"I have a friend and we are both in many of the same classes. He did the internship recently. He suggested I do it as well, as I'm going for my law degree," she said.

Sanchez had help from a couple of friends in graduate school on writing her essay. She said the questions had to do with Latinos, change and coalitions.

"I'm very interested in immigration law and immigration reform," she said. "I also drew from my own experiences growing up in a small town and some of the issues I've dealt with."

Sanchez found out earlier this year she had been accepted to the intern program.

Then came the waiting, where she held her breath to see which senator would offer her an internship.

"I hoped I would get a senator with my same ideals," she said. "Either way, I was excited, but it was scary. I think getting someone with similar ideas is just more comfortable."

Sanchez will intern for Democratic Colorado Sen. Mark Udall, along with several other students from the CHCI program. She is, as far as she knows, the only Nebraskan interning this fall with the program.

The internship will offer Sanchez a look into the making of policy and law, something she is very interested in as a future law student.

"I'm very passionate about immigration law, but like to stay well-informed in politics," she said.

Sanchez said her future plans include law school with a degree in business law. She will graduate in May with a degree in business and a minor in political science.

As an intern, Sanchez will do basic office duties. She said she will answer calls, and mail, and give tours to constituents from Colorado.

"I'll get to sit in on committee sessions the senator is dealing with and if I have free time, I can sit in on other sessions," she said.

Sanchez would like to be in Washington and see the immigration bill

make it out of the House.

"My friend was an intern when the Senate passed the bill," she said. "It would be amazing if I was there and they signed something. It would definitely be a memory for the books."

Sanchez will be in Washington by the end of August and is looking forward to meeting new people and learning new things.

She admits one of the reasons for applying for the internship is to get to know other like-minded individuals.

"It can be hard to find people that share the same views as you in western, or even eastern, Nebraska," she said. "Being exposed to the political system in Washington will be a way different world."

legal obligation to support children or other dependents.

#### What information is included in my application for nomination?

Your applications to the academies and for nomination will contain some personal in-formation including a personal letter or essay, your transcripts including your ACT/SAT scores and any information that will assist the academies in granting an appoint-ment.
