She clarified that this will be the second year that they create this float however due to a rise in prices she has submitted a request for funds. After a brief discussion the commissioners noticed the lack of a fiscal agent on the application submitted by Commissioner Leticia Rodriguez. Commissioner Adi Nancy-Dobbins

offered to add her organization as the fiscal agent for her request. The Commissioners agreed to this proposition and moved to approve the request.

#### XIII. COMMISSIONER REPORTS

- Aida Evans: Commissioner Aida Evans reported that she has been continuing her work with Catholic Social Services food pantry, as well as assisting families in the courts.
- Sandra Lopez: Commissioner Sandra Lopez attended the planting seeds conference where she was able to learn how to better help rural community members. In addition, she has been fulfilling her regular duties at Catholic Charities, she noted that due to a grant that they received from the Bank of America they have had to send out surveys that ask for people to report their status. She added however that these surveys were entirely optional and not mandatory.
- Adi Nancy-Dobbins: Commissioner Adi Nancy-Dobbins has been working with the city of North Platte to renovate the northern side of town. She shared that the current plan for the space is to fill it with public spaces where the community can congregate with one another. Some of the spaces she shared were a hydroponics greenhouse which will be open to the public, with a community center to follow in 2026 and potentially a business incubator to provide entrepreneurs a space to launch their businesses.
- Jaime Suarez: Commissioner Jaime Suarez has been working with One World to maintain the organizations presence in Omaha, as part of this work he has assisted in the building of a new headquarters in South Omaha to keep it local to the community.
- Leticia Rodriguez: Commissioner Leticia Rodriguez has been organizing the fourth of July event in Madison. She has also been assisting community members with prescription prices by helping them find coupons and ways to acquire their medications for cheaper. She added that she has been helping a grieving mother plan a funeral for her recently deceased child.
- Marilyn Schacht: Commissioner Marilyn Schacht has been working with the Mexican Consulate in Omaha to better help her community. She has also continued her work on streamlining the licensing process for immigrants, towards this goal she and ED Arriaga met with the director of the Nebraska DMV.
- Lali Sage: Vice-chair Lali Sage assisted in the creation of the new commercial for the Nebraska Commission on Latino-Americans. She also provided a report on the department of labor to provide the commissioners on some initiatives that the department has undertaken.
